### It's Time to Renew

#### **Christy Howard-Steele**

Several significant changes are being made this year to the renewal process and fees. These changes were outlined in the February Town Hall Meeting with President Tom Cusack and in a separate email. Here are the major changes to the 2025 dues:

- Dues are increasing this year for all types of membership except faith communities.
- ♦ FCM dues remained unchanged for many years. This year the dues are being increased to hire critical staff positions such as an executive director to tend to regular operations. We have realized that as we have grown a purely volunteer organization is no longer feasible.
- FCM's renewal season for 2025 begins September 1st and will end October 31st. All renewals after October 31st are late.
  - ♦The early bird discount is being eliminated.
  - ♦Beginning November 1st, though you will still be able to renew, an unwaivable late fee of \$150 will apply.

As always, FCM aids members who wish to renew during the regular renewal period who are experiencing financial difficulties. Renewal encompasses both completing your annual report and remitting the appropriate fee. While your current 2024 membership does not end until December 31, 2024, the renewal season runs September 1 through October 31, 2024, to avoid yearend busyness.

If you do not believe you will have the money to renew by October 31st, it is more helpful to both FCM and you to contact your Regional Vice President to request a partial or full waiver of your dues. Renewing your membership well into 2025 perpetuates an unnecessary hardship. You will still need to complete your annual report within the established time frame to maintain your membership status. It is our policy and practice not to deny members renewal because of financial hardships.

#### **Ministry Listing:**

When you renew, you are entitled to a free website listing of your ministry under three of the website's listed categories. Check up to three (3) categories. You will be listed by state, city, name, phone number, email address and personal website if you have one.

To renew your membership for January 1 to December 31, 2025: follow the convenient method listed below.

Commissioning and/or Endorsement faculties end December 31, 2024, if you do not renew.

\*Please note in order to renew, you need to sign into your profile on Realm. If you have previously signed in and created your unique password, you can just follow the steps below. If you have not yet done this step, email connect@fcmmail.org or the Vice President of your region, and they will be happy to send you an email link to get you started.

If you forgot your password, follow the "Forgot your password?" prompt at the login page as we are not able to do password resets.

#### Renew from your Realm Profile Account

- · go to www.onrealm.org
- · log into your Realm profile using your email address and a password you created
- from your profile page, go to the Community Page, click "Events"
- click on 2025 Membership Renewal
- type your name in the "Add Registrant" box
- select the type of membership you are renewing (general, commissioned, commissioned and endorsed, faith community)
  - answer all the questions that follow and click Next
  - pay the registration fee (credit card, debit card, or electronic check)
  - · Click "Register"

\*Please note: The renewal process must be completed in one sitting as there is no "Save" feature within Realm events. All questions marked with an asterisk must be answered or you will not be able to advance to the payment page.


#### ANTOINETTE MAROLD, COMMUNICATION

# Strategic Plan Decisions...Big decisions

At the July Circle of Directors meeting, the Circle made several decisions in line with the results of our Strategic Planning process. These decisions are in response to FCM's continued growth. This growth has put pressure on our volunteer leadership structure, which was developed at a time when FCM had a much smaller number of members. Today our 600 strong individual membership does not allow for leadership made up solely of volunteers. Organizational Goal...move from volunteer to paid staff

First, the Circle voted to acquire the services of an Executive Director, part-time. This is a major change from our past. The leadership role, held now by the President (within the Executive Committee), has become a part-time job. With FCM's demographic of members already holding jobs, adding a volunteer part-time job on top of a member's full-time job no longer works. A committee is being formed to develop the position description and find the best candidate for this new position.

In addition, the need to hire the services of a bookkeeper to record FCM's financial transactions has also been accomplished.

The Circle has also made the decision to change the leadership selection process for the positions of chairperson and president. The chairperson, currently nationally elected, will now be appointed by the Circle, from within the Circle. The same process will appoint the new president, if the Circle decides to retain a president after FCM obtains an Executive Director. A Bylaws Committee is now working to implement this major change to remove the need to solicit candidates for these offices.

### Regional structure

Bringing on more volunteers to serve the regions by working with the current VPs was a key objective here. This goal needs more structural work and more willing FCM volunteers. Please reach out to your VP.

#### Connections

The Circle is working towards having more virtual and in-person gatherings to foster community. We need experienced members to come forward to be part of the National committee planning gatherings. Consider helping this way.

#### Name

The Circle has completed discussion and analysis of the name of FCM. The Circle has affirmed our formal name as The Federation of Christian Ministries and our marketing name will be FCM. This is like Federal Express, being known as Fed Ex. Thus, we preserve our formal name, responding to widespread membership support, and we preserve the wide recognition of our name, FCM. Thank you all for participating in the discussion of our name. The Circle has also decided on a guide for the logo of FCM that we offer, so we present a unified image in our marketing. #### Social Media




#### Newsletter

### FCM Endowment Fund's First Disbursement

FCM Endowment Fund's first disbursement was used to provide grants to those who needed some financial assistance to attend the National Assembly. ### FCM's Permanent Endowment Fund Announcement



American Christianity is in crisis. Vast numbers of American Christians have singled out a certain political identity as "endorsed by God" and cast those who don't ascribe to the same political belief as being at odds with the Church. This merging of Christian faith with a political identity is often referred to as "Christian Nationalism," but the name doesn't capture the complexity of it or the danger it represents. That danger is often discussed as a "threat to our democracy," but what is rarely discussed is the threat it represents to the Church.

To be clear, Christianity is not the problem, and having one's faith inform one's political beliefs is not the problem. The problem is the intertwining of a Christian identity with a political identity such that it can be hard to tell where one ends and the other begins. "Christian Nationalism" is not a religious or even an exclusively political movement. It shapes our culture, civic life, and religious practices more than we realize and has put the country on a dangerous anti-democratic path that threatens the country's and the Church's future.

GOD & COUNTRY draws attention to this dangerous moment in a way that respects the millions of Americans who are inadvertently subscribing to some subtle forms of Christian Nationalist belief. GOD & COUNTRY is a window into the pervasive problem driving conflict and division in today's political and religious institutions. Ironically, Christian principles may offer the best way out.



And in case you haven't heard it today: you matter, you are loved, and we're so glad you're here with us. Summer is here in all its glory! The bees are busy, and the flowers are in full bloom. If you are a gardener like me, I hope you are starting to see the fruits of your labor. One question asked at the assembly was, "Why FCM"? I asked one of our regional members who joined in the celebration and commissioning service to share his response. Please see Rev. Will Horne's response below.

### Why FCM?



I have been on a long journey of trying to follow Jesus. From "giving my life to the Lord," at age 7 to becoming 'unashamed' in the Christian Hip Hop movement of my teen years, to leaving the Southern Baptist Convention at 18 to go explore, to theology degrees, to community movements, to being pushed out of church spaces for being "too progressive," to navigating the world of hospital chaplaincy - it's all been a journey of trying to follow Jesus. A spirituality open to the work of the Divine requires a willingness to journey, a willingness to expand, to change.

But our religious and institutional spaces aren't too keen on "journeying," (despite "Journey" being a hip evangelical church name), we are too stuck on power and control, it consumes us. We want to guard boundaries, protect the truth, and watch out for "slippery slopes." For many, "journeying" disqualifies a person from ministry. And I found myself in this place, committed to "the gospel of Jesus the Christ," but wondering what my wandering meant for my ministry.

Somewhere on this journey, I was introduced to FCM. At first, I was hesitant. I loved the values - belonging, compassion, empowerment, equity, and mindful living. But I've navigated the church world enough to know values don't often match practice. Cool history, but I've seen "church splits," new startups, and community movements. Once you become legit - power, control, and fear will choke out values, vision, faith (Jesus said something like that). Just another group talking a good game, wanting to use me until the journey leads me to question the powers that be (I'm not a cynic I promise, maybe). I joined with hesitancy and slowly began to get to know FCM. A few prayer meetings, getting to know a few individuals, walking through the commissioning process, all while remaining cautious. And as I continued, I began to think this group is incredibly odd, hard to pin down, and kind of great.

And it wasn't until I came to the national assembly in Atlanta that it all began to come together. "Being on the journey," doesn't disqualify you from the highest levels of ministry, but it empowers you for it. FCM not only allows freedom on the journey but fosters it and leverages it for empowerment and belonging. FCM seeks to follow Jesus while refusing to succumb to the need for power and control. They entrust the Divine to guide the journey, to lead us to the right "slippery slopes," to protect the deepest truths of our shared humanity and the God who meets us in it. That's why I am with FCM - a home willing to be mobile, a people willing to trust that God will guide the journey, a group to empower the highest level of gospel ministry.

Like Rev. Will, I, too, was drawn to the values of FCM. I hope we will all find time to rest and enjoy this phase of life this season.
