I wish to thank Ken personally for his service not only as Treasurer of FCM for the past two years, but also as a past Vice President of the Southern Region and Secretary of the Circle. He has been a blessing to so many and I am grateful for the way he has touched my life. Given the seriousness Ken's situation, we needed to act quickly and are fortunate to be able to be able to announce that **Susan Ross** has been appointed as Treasurer to complete Ken's term. One of the major agenda items at the July 2015 Circle Meeting was our Strategic Plan. President **Tom Cusack** led that discussion in setting the priorities for the next year, drawing upon the strategic goals and objectives. Priorities by the Circle included;

- Recruiting and establishing faith groups, as defined in the bylaws as a church, a faith group, a service group.
   This has the possibility of including Catholic parishes that have been closed or filling the needs for a community of faith in a locality.
- Social Justice initiatives
- Support of those in professional ministry and membership as a whole, which generated discussion around the
  possibility of a chaplaincy faith group.


These priorities led to conversation regarding new paradigms of ministry such as internet-based groups. Members of the Circle also shared their reflections on emerging definitions of church in the post-denominational/new reformation age.

In the light of these priorities the Circle has established two new positions. The first is a regional position, the <u>Area Representative</u>. Given the size of our regions it can be difficult for the Vice Presidents to reach out to all members of the region. The Area Representative will assist the Vice President in building community and enabling connection between members in the local areas of each region.

The second is new within the Circle: <u>Director, Group Member Affairs</u>, who will serve as a liaison connecting groups within FCM, providing assistance to communities who wish to develop a faith group, for example a community whose church has been closed. In August, the Circle appointed **Becky Cartus** to assume this new role. We are in the process of assembling a team to work with Becky in the development of this part of the Strategic Plan. Those individuals include **Joe Ruane**, **Tom Quinn**, **Marie Sweeney** and **Eileen DiFranco**. More information will follow.

Finally we are extremely happy to announce that due to the generous donations members have made this past year, we will NOT raise membership renewal fees this year. This makes the third year that increased donations have made increased fees unnecessary. I am deeply grateful for the many people whose kindness has allowed us to keep renewal fees at their current level. You are a gift to many in the FCM community who find it difficult to cover the cost of membership. ### A WORD FROM THE PRESIDENT...Tom Cusack

### Inreach

Inreach is the most difficult of the three actions of "Reach, Outreach, and Inreach." My last two Newsletter articles discussed **Reach** and **Outreach**. This article deals with the critical action of **Inreach**. And... what is **Inreach?** 

We in FCM make up a religious body and most of us describe ourselves as Christians. This label brings with it some expectations of knowledge of and relationship with Jesus, and recognition that there is a spiritual realm that is significant, in which we dwell. *Inreach* is the

systematic effort to come into conscious contact with that spiritual realm. It is a very challenging effort to undertake. But it is critical that we as baptized Christians make that effort... especially since many of us are Christian leaders.

I'll share my experiences here, so I don't get into preaching to the choir. A significantl experience in my spiritual evolution occurred in 1986 when my wife and I publicly announced to the congregation the shape of our conflict with the Catholic pastor of the parish at which we had been providing music for five years. This public announcement, as we thought, resulted in our being fired from our music ministry. About three weeks later we came into contact with the Indian spiritual master **Sri Chinmoy**. We both followed this initial contact by becoming his meditation students, and we have been students since about 1988. During these 27 years I have learned about the discipline of meditation. And it is discipline which comprises a large part of the **Inreach** challenge. Here I'll lay out a simple way to approach meditation. Even if you are experienced with meditation, another look at this difficult discipline is often helpful.

First, set up a place for your spiritual discipline. You may have a table or desk in the corner of the room. I suggest that when you do your spiritual activities at home, that you do them there. This structure gives you feedback that now it is time to concentrate on your spirituality. This setting should have a lighted candle, a picture of Jesus, and the Bible. Now, choose an amount of time. Let's say it's nine minutes. Divide this time into three parts. In the first three minutes read Scripture or the writings of a saint. This puts your mind into the context of spiritual activity. For the second three minutes, pray. We know how to pray; that's our long suit. Jesus really likes us to pray, although he pretty well knows what we're going to say. During these three minutes of prayer, you can get in your two minutes for FCM. Those are the first two minutes of my formula 2 X 2 4 FCM. That leaves you a minute of free-form prayer.


Next we do three minutes of meditation to complete the nine minutes. Here are three simple ways to meditate with Jesus. First, look at his picture with your eyes half open and half shut. This posture gives physical feedback that it is a special time. While looking at his picture have your right hand on your knee and be aware of your right hand "holding the hand of Jesus." Form the intention to have your mind be silent and in sync with him. When your mind wanders, as it definitely will, realize that it has wandered and simply come back to the awareness of your hand holding his hand. Three minutes and done. Repeat every day for the rest of your life, with variations.

Second approach: be aware of your breathing, four breaths in and four breaths out...uniting your breath with the breath of the Holy Spirit so that you can become more like Jesus. If your mind wanders, bring it back to your breathing. Keep counting your breath slowly, until the three minutes are up. Done.

Third approach: give your mind a simple activity when you focus your attention on Jesus. Slowly repeat a meaningful phrase over and over very slowly. This gives your restless mind something to do while your inner attention is focused on a quiet unity with Christ. When your attention wanders, simply come back to the slow repetition of the meaningful phrase. Examples? Jesus be with me. Jesus let me walk with you. Jesus help me grow. Mary be my guide. Mary show me the way. Mary help me live and love.

After while you'll discover that nine minutes doesn't give you enough time. Then keep working at it and expand your time of meditation. I invite you to let me know how you're doing; let me know if you have some experiences you can share with me. I know that some of you are acting on 2 X 2 4 FCM. In addition I think it would help us all is if we had a nice structured prayer that was two minutes long for FCM. Perhaps some of you could write two-minute prayers for FCM and send them into me or the editor, and we'll put them out as a resource for the rest. Progress in the spiritual life is very difficult, and so if you have an inspiration that might help others, please share it.

So that gives you an example of the action of **Inreach**. If you ask Jesus to come and remold your spirit, your heart and your mind, you will find that over a course of years you'll be able to see changes within. They will be good changes. Blessings to you and FCM.

How can I help you? That is the main idea of this article, but I confess yhat giving back is a primary motivation behind my decision to accept the Northeast Regional Vice-Presidency. I joined FCM five years ago, looking for a spiritual home and like-minded ministers and pilgrims. I have found both in FCM, and so I look forward very much to meeting and serving more of my Northeast colleagues.

A short note about me, perhaps helpful in your figuring how I can be of service. I'm a lawyer ("What's black and brown and looks good on a lawyer? A Doberman pinscher"). My ministry is visiting psych wards to insure the rights and humanity of the patients are respected. Other ministries have included working with the homeless, juvenile delinquents, and with neglected/abandoned children. I'm a deacon in the New York archdiocese, married for 43 years to Donna Piazza Pellegrin, and father of six adult children.

Can we grow together? Tom Cusack recently wrote about the importance of connecting with each other. "Networking among FCM members is a foundational aspect .... We have to feel internal community.... As a religious body we have a responsibility to form internal community." This desire is strong in me, and is found in our member applications time and again. How can I help you? I hope it will be by facilitating local area get-togethers and liturgies and meeting you.

This is an exciting time to be a member of FCM. Tom Cusack points out that FCM is no longer simply a ministerial association, but "a religious body of a Christian nature." We are "a convention of churches." I am personally searching for a local small faith community. Tom tells me and us: "Since we have a membership that includes many trained ministers, please consider beginning small faith communities yourself that might meet once a month under your guidance. These little churches could meet in a home and they may grow. Those who consider themselves 'spiritual but not religious' may be greatly benefited by these small faith communities that you start. FCM is uniquely positioned to minister to those people. We need your creative thoughts of how to do this." Can I help you with this? FCM has resources for this purpose. May I share them with you? Other Resources as well are planned for the website that I know you will find invaluable.

What's going on in the NE region? Pat and Paul Stubenbort said it so well: "Most importantly, all FCM members ministering: in hospitals, in prisons, in churches, hospices, counseling, teaching, in half-way houses, in soup kitchens, at military complexes, and wherever else the Gospel of our Lord lures us to make our ministering presence felt."

Let me here thank Pat and Paul profusely for their unstinting and invaluable help to me in assuming the VP duties. They are exemplars: their service to FCM hasn't stopped. They will be attending the ordination of Women Priests in New Jersey, and gifting the new priests with membership in FCM through which they will be able to effectively minister where God calls them. We have other new members now joining and seeking commissioning thanks to the fertile work of Pat and Paul.

#### Actions You May Consider. I offer six:

- 1. Please call me (914-592-4275 work, 914-328-9732 home) or email me (NortheastVP@FCMmail.org) to discuss how I may help and how we may get to know each other.
- 2. Continue to do 2 x 2 4 FCM (two minutes of prayer and two minutes of meditation for FCM) daily.
- Consider being an Area Representative, wherein you help yourself and those FCM members in your local area. Please call or write me for more information.
- 4. Commit to only two hours' monthly service to seek out local small faith communities.
- 5. Join the FCM group on LinkedIn. Join and a part of the online dialogue of your FCM sisters and brothers. You need only request to join the group. Our Communications chair Antoinette Marold will respond to you and you're in.
- 6. This last one is good. Consider contributing to FCM. This way we can all give back.


We look forward to a continued ministry partnership with Cindy, Lee and Salvador and pray that God will continue to bless them in their ministries.

Then she offered a personal testimony to her relationship with the Divine and service to humanity as a chaplain. Describing her ministry as a chaplain she explained, "Tango literally means reserved ground or closed space. What is shared between the two dance partners cannot be known or seen by the outside world. It is an experience that only the two dancers bear witness to, finding themselves in the vulnerability of an embrace attempting to navigate their way through a crowded dance floor to music that each of them most likely interprets differently.

As a chaplain and a minister of God, I believe I am called to facilitate or help to create reserved ground in which to encounter the Holy and closed space in which to experience that which is most sacred. As a chaplain, I have the opportunity to be invited to share in the work of God in people's lives. Whether it is to speak a blessing

over a newborn baby, celebrate a successful surgery, offer prayer and a listening ear when the treatment was not successful or grieve with a family over the loss of a loved one. I have the privilege and honor of bearing witness to the most sacred and holy moments of life."

As you might understand, the event was truly an experience of standing on Holy Ground!

When you LOGIN you will see a Members Only tab on the top right of the screen.

- 1. First on the list is a Ministry Listing Form. If you would like your ministry listed on the FCM website, complete the form. This is a benefit of membership. You can select 3 ministries to be listed under at no cost to you. You will be expected to update this request in February of each calendar year. You can complete the form online or download the pdf and send it in to the FCM Central Office.
- Second on the list is the Baptism Registry Form. If you preside at a baptism you MUST register the baptism with FCM. Complete and submit the form.
- 3. Third on the list is the Marriage Registry Form. This is not mandatory but suggested.
- 4. Fourth on the list is the Holy Union Registry Form. This is not mandatory but suggested.
- FCM Newsletters The most recent newsletter along with an archive of several years of newsletters are available. If you have the time, it is helpful to read some of the past newsletters to get to know us,
- 6. An online membership list. This is not a complete list of members and their ministries, only those who have registered in the login area.
- 7. FCM membership list. This is a listing of the members and group members . It is updated every 3 months and can be downloaded by members. Please do not share this list.

# New Officers Bring Talent, Commitment

By now, anyone reading this is aware of the changes that have taken place of late at FCM. Amidst a flurry of activity the leadership of our organization is in new hands and a figurative glance around the Circle reveals plenty of new faces. Elsewhere in

this issue regional vice-presidents are introducing themselves as is the newly-created coordinator of group affairs. Rounding out the group of incoming officers are our secretary and treasurer, positions that are now filled by members from the Southern and Great Lakes regions respectively.



Filling the capable shoes of **Bea Broder-Oldach** is **Diane Dougherty**, an ordained Roman Catholic Woman Priest serving in Atlanta. A self-described feminist, liberation theologian and human rights activist, she states that her ministry is centered in serving the cause of justice for women through the light of the Gospel. "Because Women Priests proclaim a theology that strengthens the recognition of human rights, I work to create communal frameworks focused on equality, remaining inside the structures of our present institution."

Diane has worked for First Metropolitan Community Church in support of the LGBTQ community as well as advocated in the legislature with Georgia Equality to quash the Religious Liberty Bill for 2015. An ecumenical leader, she is an active member of the Education Committee of Concerned Black Clergy, joining in an effort to support education and build coalitions throughout the state to inform voters about pending legislation that may weaken public schools. In addition to performing baptisms, weddings, burying the homeless and conducting healing services, she served along with 70 women from twenty nations as a Human Rights Defender in a workshop held at the Carter Center.

"My Church has become the Church of the Visitation," she explains, "wherein I go to meet those on the margins and gather around them those who can fulfill their needs. My ministry is mobile-embedded with numerous conversations about what an egalitarian church would look like within a discipleship of equals."



Susan Ross, who makes her home in Indianapolis, steps into the unexpired term of Ken Knapp bringing a varied set of skills. After college she taught high school and coached collegiate softball and volleyball before moving into the business field. Working as CEO of a small financial services office in Fort Wayne, she enrolled at Bethany Theological Seminary in Richmond, Indiana, obtaining her MA in Theology in 2008

Five years ago came a significant change in employment - and climate! - when Susan found herself in Palm Harbor, Florida in a chaplain residency program. As an inpatient chaplain she saw first-hand the spiritual needs of patients, families and staff. Eventually moving into a weekend and PRN position, she furthered her education and experience with her presence at deaths and making bereavement calls.

In January of 2013 she returned to her Hoosier roots and has worked at St. Vincent Hospice in Indianapolis, providing support services to staff, patients and families alike. Her efforts there focused on areas as diverse as memorial services, assessing the spiritual needs of patients and representing the facility in the community. This past March Susan was designated Associate Certified Chaplain and anticipates completing the requirements for full board certification within six months.

Even as we commend these two for their willingness to serve, it is important to recognize the diversity in life experience and ministerial dedication they represent. Each in her own way, Susan and Diane stand for the breadth of background that one finds throughout our membership. ### **Taking Calls**

A call center . . . sometimes I feel as if I live inside a blinking, winking call center. Taking on incoming communiqués. Receiving important messages. Following up with timely responses. A member since 2012, a minister commissioned to ministry in 2013, I now serve as installed minister at the Unitarian Universalist Congregation of Smithton in Smithton, PA.

And, yet again, the center of my life blazes to life with the chance to answer the new call set before me. The FCM Circle of Directors appointed me as the Director of Group Affairs, a brand new position within the organization to focus on and foster the faith communities already in existence or still on paper. To provide a sacred space for the disinherited and a holy place for the marginalized. And, above all, to share the good news of the greater One and Many, with all of its holy mystery and with all of its divine glory. And, I believe, that in doing so, we, at FCM, will expand the presence and the purpose of our denomination, across the country and out, into the world.

Thank you for the chance to lead such an awesome charge. Gotta go . . . I hear the phone ringing.
