News From the Circle of Directors

- As some of you may have heard from your Regional Vice Presidents, the Circle has decided to offer commissioning four times per year. That means that in addition to the Circle's regular meetings in February and July, the Circle will also meet virtually in November and in May to consider candidates for commissioning. Applications will generally be due one month prior to the meeting. Specific dates will be published on the website. The Circle made this decision in light of the high volume of candidates being presented in February and July. We hope that this will allow the candidates to be presented more evenly throughout the year. Endorsement will continue to be offered three times per year; February, July, and November.
- Applications for new members, individual and faith community, are being moved to Realm rather than continue as a separate process. A link on the website will connect the new member to the New Member or New Faith Community Member Application Event that has been created in Realm. The new member will be allowed as a guest to complete their application in Realm. This will enhance communication and further streamline our processes.

FCM Owns an Endowment Fund

The Circle voted final approval of the Endowment Fund in February, 2018. Today, its assets are over \$50,000.

What Is the FCM Endowment Fund? We can think of an endowment fund as a savings account whose principal can never be touched. Only a portion of the interest and earnings can be used every year.

Why Have an Endowment Fund? Our FCM Endowment Fund will help ensure FCM can have the financial stability to carry on far into the future.

An endowment fund also sends a message to people who appreciate FCM. The message is that FCM will endure. They can see that FCM manages its resources responsibly, plans efficiently, and will likely survive any crisis. The Fund gives our members and other donors the comforting option of giving a gift that keeps on giving well into the future.

The gifts you give are recorded and tracked by the FCM Endowment Committee. Over time even small gifts begin to add up.

Larger accumulations of gifts that equal \$10,000 or more may be designated "Named Fund." The donor designates a Named Fund to honor people or institutions by name.

Gifts of \$25,000 or more are called "Legacy Named Fund." The earnings of a Legacy Named Fund can be directed by the donor to support the donor's specific goals, with the acceptance of the Circle. Our Endowment does not yet have a Named Fund nor a Legacy Named Fund. You can be first!

"Tribute Gift" in any amount is a meaningful way to honor the life of a friend or family member, living or deceased. It also provides the opportunity to make a donation to celebrate a special occasion - birthday, anniversary or wedding. Make a gift using our secure online giving form, or print off a mail-in form. We will notify the honoree or honoree's family about your gift.



Prayer Gathering Continues Weekly

Every Thursday at 8:00 PM EDT 20 to 40 FCM members gather together in a video conference to pray and meditate. The Gathering idea originated early in the pandemic in discussions between Tom Cusack and Anthony Capone. Tom hosts the Gathering and Anthony, our FCM Prayer Ministry Coordinator, leads it and administrates. The zoom meeting is characterized by one half hour of prayer and meditation followed by open discussion for one-half hour. The opening spiritual half hour is led by a member of FCM who has volunteered to lead. The volunteers are from across our five Regions.

Many participants are regulars; they are on every week. This has led to the building of an online community. We recognize one another and know elements of our new friends' pathway through the pandemic. The community building occurs in the second half of the hour, from 8:30 to 9:00 PM. Discussion, sharing and reflections take place in an open format.

During the Gathering, participants add prayer intentions and other communications to the Chat facility. Anthony captures the chat and then forwards the prayer requests to the growing FCM Prayer Ministry.

We offer thanks to those participating, and we invite you to join us for a time of spiritual concentration with other FCM members. Emailed invitations go out weekly.

Two FCM ministers stood side-by-side on the platform in Philadelphia during the 2018 General Assembly Commissioning Ceremony. They never spoke or crossed paths the entire weekend event. Months later, Jacqueline Cook accepted a staff chaplain position at Geisinger Holy Spirit Hospital in Camp Hill, Pennsylvania. Justin Ferko, a recently hired GHS staff chaplain, was assigned to assist with her orientation process.

The newly acquainted chaplains made small talk as they rode the elevator to Justin's unit on the eighth floor. As they placed their binders down at the nurse's station, Jacqueline asked, "What denomination is your ordination through?" Justin replied, "It's a group called the Federation of Christian Ministries." Jacqueline's eyes widened as Justin explained, "My CPE Supervisor told me about FCM and their wide embrace of all people and support for all people's gifts in ministry." Jacqueline exclaimed, "Me too!" Justin asked, "What do you mean?" She replied, "I'm with FCM too! What are the chances?" TEA FOR YOUR SPIRIT

During their time together at Geisinger Holy Spirit Hospital, Justin and Jacqueline co-hosted the first ever "Tea for Your Spirit" on the Maternity/NICU Unit. "Tea for Your Spirit" is designed to create a relaxed space for staff to visit with each other, engage in reflective activities, enjoy snacks, and talk with chaplains. They also developed a group called "Sacred Space" for the Behavioral Health Inpatient Unit. "Come as you are with whatever you believe," is the motto for this all-inclusive spiritual group. Justin shared, "I love seeing patients supporting one another, claiming ownership of the space by setting up chairs, lighting battery-operated tea lights on the tables." Jacqueline added, "Every group is unique. We show up with a general program and follow the patient's and Spirit's promptings. It is a beautiful thing to experience."

Justin and Jacqueline became FCM ministry peers in 2019 and Justin presided over Jacqueline's FCM Endorsement panel. The two attended the FCM Northeast Regional Retreat at Eddy Farm last October. In March of 2020, Jacqueline accepted the position of Chaplain/Director of Pastoral Care at Claremont Nursing and Rehabilitation Center in Carlisle, Pennsylvania. In September of 2020, Justin celebrated his 2-year anniversary at Geisinger Holy Spirit Hospital. Although the two no longer work at the same facility, they remain ministry peers, good friends, and trusted confidants.

I often find myself engaged in one-on-one conversations about resiliency and thinking about what it is about *people* that helps them endure stressful situations that oftentimes are prolonged.

This year has proven to be challenging in many ways. Prolonged travel restrictions keeping us from seeing family and friends, tumultuous times, the added work stress of needing to produce on-line resources and media, not being able to meet in-person for coffee, encountering divergent views and attitudes toward social-distancing, seeking and waiting for physical healing have been several of many stressors.

I wonder what it is that has helped you get through this time. I know for me it has been helpful to remember my roots—from where it is that I've come. Isaiah's words for a discouraged people during the difficult time of exile, "Look to the rock from which you were hewn," have been helpful for me. The rock for me is God: my spirituality and all the people and events that have helped shape me. God in providence has led me to where I am, in John Newton's famous words, "through many dangers, toils, and snares, I have already come," I know that the same grace that has brought me this far will continue to guide my life and path. This too shall pass. God hasn't brought me this far to leave me here. I will get through *this* too.

Through this time, which in many ways has been a pause, I became profoundly and acutely aware of my need for connection. To meet that need, I began to meet weekly with a spiritual director as well as to rekindle several friendships that had gone uncultivated due to my pace of life. Intentionally connecting with my spiritual director as well as several friends and family members, even if over FaceTime, phone, and Zoom conversations, proved to remind me that we truly are "in this together." The "alone" factor is truly an illusion—that illusory thought that can become our default that says, "I am in this all alone" and "There is no one who understands." I quickly realized that everyone is carrying their own cross, their own burden. Burdens of under-employment, a traumatic injury, postpartum depression, the death of a loved one, loneliness, etc. It is in the sharing, the knowing, the loving and the praying that we become stronger and more resilient together.

As I seek to be a connector for those of all ages in my midst, one thing is certain, and that is our need for connection with *one another*. It is in the isolation that one's path becomes dark and unbearable—even to the point of ending it all. Yet, it is through meaningful conversation and checking in with *people* where light, health, wholeness, and hope brighten the human spirit, making each of us better and more resilient.

Northeast Region Report

One of our regional members, Chaplain Terra Epps, was recognized for her outstanding pastoral work during the on-going Covid-1 pandemic by her hospital, The University of Maryland Medical Center. Here is an excerpt of what Terra wrote on the hospital website:

"Each day continues to bring challenges, new learnings, adjustments, and varied emotions. Yet, I strive to maintain gratitude. I am grateful to work for an institution that values the essential nature of the professional healthcare chaplain. I am grateful that I can continue to support patients, families, and staff, whether it is over the phone, via secure Zoom video conferencing, from our newly developed UMMC pastoral care Facebook group, or during inperson visits. I am grateful for the challenge and space to continue to develop innovative ways of providing spiritual care in times of such uncertainty, anxiety, grief, and loss."



Our region is now meeting via Zoom every month. On September, 13 of us participated in a workshop on "Self-care during Covid-19." The workshop ended with these suggestions:

- Look upstream, rather than downstream (Respond, rather than react)
- > Take fuller charge of the need for intentional balance in your life (Live the Serenity Prayer)
- > Set limits in what you will do and what you will not do at work (Remember to say 'no' to some things in order to say a deeper 'yes' to other things)
- > Work at knowing yourself better, however that happens best for you (Therapy, Spiritual Direction, or Peer Support)
- > Exercise more and eat well



On October 10th, we began a 3-part series on marriage: theology, prep, and counseling. Our first presenter was the Rev. Dr. Shanon Sterringer, ARCWP. Shanon is commissioned member of FCM, ordained priest, and the pastor of The Community of St. Hildegard (https://hildegardhaus.com) in Fairport Harbor, Ohio. She is also a professor at the People's Catholic Seminary (https://pcseminary.org). Previously, Sharon has led marriage prep for the Cleveland Diocese.

Grounded in feminist/relational theology, Shanon presented material on the history and theology of marriage as a contract and a sacrament. She also introduced us to St. Hildegard of Bingen's unique core value of "viriditas," (greening power that integrates body, mind, and spirit). Feedback was very positive and we are so grateful to have Shanon as a colleague in FCM and for her generosity in "vcrossing" FCM regional lines!



On November 14th our presenter will be **Thomas Quinn**, former president of FCM and psychotherapist, who will help us with the psychological dynamics that goes into marriage prep and marriage counseling. Tom has been a commissioned member of FCM for many, many, years.



On December 12th our presenter will be FCM member John Haag, who will help participants share their experience of doing marriage prep and counseling and open a discussion on the future of marriage. John is a long-time commissioned member of FCM.


