As FCM has expanded and matured as an organization, we have recognized the need to provide for our long-term financial stability through the establishment of a permanent endowment. As stated in our policy, "The Permanent Endowment Fund the Federation of Christian Ministries" (February 2018) has the following purpose:

"The purpose of the Fund is to enable FCM members, organizations, and friends to express their commitment to Christ through gifts that will support in perpetuity the inclusive and ecumenical missions and programs of FCM."

Serious Planning for Endowment

Many FCM members have decades of experience with ministry as an FCM member. Their ministries are supported and ratified by FCM. This short article is to spur some thought and consideration about some ways you could return support to FCM through its Endowment Fund.

Simplest way to help: life insurance

You probably have some life insurance. You can add FCM to its beneficiary clause by obtaining the correct forms from your company (call them up!). Add FCM as a partial beneficiary (like for 25% or 50% of the proceeds) or for the full amount, if your earlier beneficiaries are no longer in need of these funds.

You could also change the ownership of the policy to FCM, and then continue to pay the premiums. Or, many policies can be made "reduced paid-up." They no longer need premiums, but they will pay a death benefit. That will benefit FCM at the time of your death.

Update your will, create a trust

Leaving money or property to FCM through a will or trust calls for the help of an attorney. Plan your gift, and remember that amounts of \$10,000 or more can create Memorial Named funds. These Endowment funds carry the name of the person or people you wish to have remembered in FCM Endowment communications. Also, amounts of \$25,000 or more create Legacy Named Funds. This money is held in a separate Endowment account. Its proceeds may be specified for a goal the donor selects, subject to approval by the Circle of Directors. An example of such a goal would be to provide an academic scholarship to a member of FCM.



FCM Endowment Committee



Tom Cusack completed two three-year terms on the FCM Circle of Directors as President in 2020. He joined FCM in 2000 and is a commissioned member. He served two three-year terms as FCM's Treasurer and remained on the Circle until he became President in 2014. In his mid-twenties, after a short time as a Catholic priest in Iowa, Tom married and entered the insurance business. He spent 15 years in Prudential's Newark, New Jersey, home office in agent training work and as a compliance manager. The bulk of his career, 26 additional years, was as an insurance agent and financial planner. He served on the board of a private school for five years. In addition to 60 graduate hours of theology and scripture study, he earned a Master's Degree in American History from Notre Dame, and he holds several insurance industry designations. They include Chartered Life Underwriter (CLU), Chartered Financial Consultant (ChFC), and Chartered Property and Casualty Underwriter (CPCU).



Anthony (Tony) Ercolano was ordained for the Diocese of Brooklyn, NY, in 1973. He served as an Associate Pastor in four large, urban parishes, as well as a spiritual director of an independent Catholic High School, over 33 years of priestly ministry. He earned a Doctor of Ministry degree with a focus on Urban Ministry from New York Theological Seminary in 2002, and a Certificate in the Management of Nonprofits from Hofstra University. He married Margaret in 2006, inheriting a family of seven adult children, 15 grandchildren, and five great-grandchildren. He then worked for two metropolitan hospital systems over the course of 13 years as a senior writer for development, marketing, and public affairs. 
